### LIABILITY WAIVER

By entering any dog park operated by the City of Olivette, I agree to indemnify, defend, hold harmless and fully release from all liability the City of Olivette, its officers, agents, partners, sponsors, contractors or employees (collectively "Olivette"), and the owner of any property upon which Olivette operates, including their officers, agents, partners, sponsors, contractors, employees and/or volunteers (collectively "City Staff") from any and all lawsuits, damages, claims, judgments, loss, liability, or expenses arising out of **1**) any death or personal injuries or property damage which I or my animal (s) may sustain or which I or my animal may cause while I am using a park under the control of Olivette, or the City Staff, or any equipment owned by or under the control of Olivette or the City Staff, or while participating in any activity sponsored by Olivette and/or the City Staff, or **2**) any death or injury which results or increases by any action taken to medically treat me or my animal.

It is my understanding that no agent of the City of Olivette or City Staff will supervise the off-leash area at any time, and that I alone am responsible for myself and my animal(s) while using facilities operated by the City of Olivette.

I also understand that the City of Olivette and/or the City Staff does not carry insurance to cover users of this park, I understand there are risks associated with a dog park including the unpredictable behavior of dogs, and I assume the risk of any injuries that my animal or I may sustain at this park.

I have carefully read this unconditional release of liability, understand, and fully agree with its contents. I also have received a copy of the membership application outlining rules for use, etiquette for dog owners and recommendation for dog owners.

## **2026 Dog Park Regulations**

The following regulations are to be followed at the City of Olivette Dog Park located at Irv Zeid Park, 9100 Old Bonhomme Road, Olivette.

1. Dog Park is open from Dawn till Dusk.
2. Dogs must have a registered current Olivette Dog License and have up-to-date rabies vaccinations.
3. Dogs must be registered dog park users for the current calendar year.
4. Dogs should be spayed or neutered.
5. Owners are legally responsible for their dogs and any injuries or damages caused by their dogs. "Owner" applies to the person over 18 accompanying the dog(s).
6. Dog feces and/or dog waste must be cleaned up immediately and disposed of properly by owners.
7. Owners must discourage excessive barking.
8. Dogs must at the first sign of aggression be leashed and removed from the park.
9. All dogs must be on-leash until inside the fenced area.
10. Dog owners must carry a leash at all times, closely supervise their dogs and at no time may the owner leave the fenced area without his/her dog.
11. Gates must be kept closed except when entering or exiting.
12. Dogs should be under voice control at all times.
13. Owners must stop dogs from digging and fill any holes caused by their dogs.
14. Remove gentle leader, halter, harness, pinch, spike, and choke collars immediately upon entering the fenced area.
15. No children 12 years of age or younger are allowed inside the fenced area; children aged 13-17 years old are permitted inside the fenced area only when accompanied by a person over the age of 18.
16. The following are not allowed inside of the fenced area:
  - a. Dogs in heat
  - b. Aggressive dogs
  - c. Dogs that are ill or injured
  - d. Puppies under four months of age
  - e. Animals, other than dogs
  - f. Food, treats, rawhide, or glass
  - g. Alcoholic beverages
  - h. Bicycles, skateboards, roller blades or skates, or any motorized vehicle, except wheelchairs.
17. No climbing on or over the fence
18. No smoking or tobacco use inside the fenced area.
19. All dog owners who fail to comply with the above rule may be asked to leave the dog park and may have their use of the facility revoked.
