Thank you for volunteering for the 2026 Olivette Youth Basketball League. Your time and services are greatly appreciated, as the league could not exist without you. This letter is to inform you of upcoming meetings and activities.

We will have equipment pickup starting **Thursday, November 19th** from Five Oaks (1200 N Warson Rd, Olivette, MO 63132). Uniforms will come at a later date as we are getting specific sizes and will not make the order until rosters are finalized. Please inform the front desk of the head coach's name & grade level when picking up equipment. Coaches can pick up their equipment on the following days. Expected Uniform pick-up will be **available** on **Friday, December 19th** (date possible to change based on delivery)

Coaches will be emailed their final roster on **Friday, November 14th**. At that time, coaches will be allowed to contact their players. Practices can begin the week of **December 1st**. Teams will be provided with practice once during the week and one weekend practice upon request before games begin.

Please note the head coach's requests will receive priority during scheduling.

These background checks are submitted to the Olivette Human Resources Department as soon as they are received and are not kept on file at The Center of Olivette. **These forms are good for two calendar years**. If you filled out a background check for the 2025 baseball or soccer seasons you do not need to return the form.

We will have an All Coaches Meeting on **Thursday, November 20th at 5:30 p.m. via zoom**. Please have at least one team representative present at this meeting as we will discuss the introduction of staff, league philosophy, coaching expectations, schedules, rules, and picture times, as well as discuss other league topics and answer any questions you may have. Coaches will be emailed a link 1 week in advance.

Head coaches receive 100% off the registration fee for their child and Assistant coaches receive 50% off the registration fee. Coaches may receive a refund solely for the child they are coaching.

## INVESTIGATIVE REPORT- Background Check

In connection with your application for employment or volunteer requirements, we may procure an investigative report about you including information as to your character, general reputation, personal characteristics, and mode of living, whichever are applicable. In the event that information from the report is utilized in whole or in part in making an adverse decision with regard to your potential employment or volunteer opportunity, before making the adverse decision, we will provide you with a copy of the investigative report and a description in writing of your rights under the federal Fair Credit Reporting Act.

The Fair Credit Reporting Act gives you specific rights in dealing with consumer reporting agencies. You will be given a summary of these rights together with this document. Upon your written request (made within a reasonable period of time), you have a right to complete and accurate disclosure of the nature and scope of the investigation requested.
